



PRE-AUTHORIZED PAYMENT PLAN

What is Northern Ontario Wires' (NOW, Inc.) Pre-Authorized Payment Plan?

This plan offers you a convenient, timesaving way to pay your electric/ water and/or sewer bill. Upon your authorization, NOW, Inc. will deduct payment for your electric/ water and/ or sewer bill from the bank account of your choice. You'll never have to write us another cheque, or waste time standing in line, you'll save on postage and your payment will always be on time (avoiding late charges).

How Does the Plan Work?

NOW, Inc. Pre-authorized Payment Plan works the same way as other payments in that they are automatically deducted from your bank account. Once the initial plan is set up, you'll continue to receive your electric/ water and/ or sewer bill, as usual, detailing all the charges. The total amount due is deducted automatically from your bank account on the due date. Final bills are not subject to pre-authorized payment and therefore must be paid directly.

Northern Ontario Wires Inc. (NOW, Inc.) has retained Cochrane Telecom Services to operate and manage the electric distribution systems in Cochrane, Iroquois Falls and Kapuskasing.

How Do I Enroll?

1. Complete & sign the Pre-Authorized Payment Plan authorization agreement hereunder.
2. Attach an unsigned cheque clearly marked "void" to the completed agreement.
3. Return the completed agreement to your local office.

Cancellation

- This agreement can be terminated, upon written or verbal notification, at any time, by either the customer or NOW, Inc. Upon termination, any amount due shall be paid directly to NOW, Inc.
- Cancellation of pre-authorized payment does not constitute cancellation of service by NOW and the customer shall be liable for any past, present or future amounts owing.

Terms & Conditions

- This Pre-Authorized Payment Plan is for the convenience of the customer.
- The customer certifies that the information provided in the authorization is correct and that the customer will notify NOW, Inc. in the event of any changes.
- The customer certifies that their bank account is in good standing with sufficient funds to cover pre-authorized payments as they come due.
- All pre-authorized payments will be drawn on Canadian financial institutions and will be withdrawn in Canadian funds.
- All information will remain confidential.

Important

You will be notified on your electric/ water and/ or sewer bill when your account has been switched to the Pre-Authorized Payment Plan. Please continue to pay your monthly bill in the usual manner until you receive this notification. If you should make any changes in your banking arrangements or need to notify us of any changes in your banking procedures, please contact our local office immediately.
